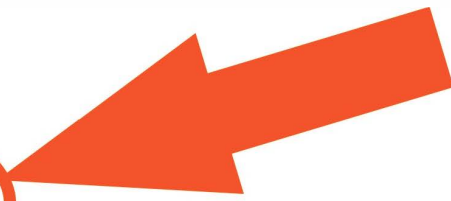

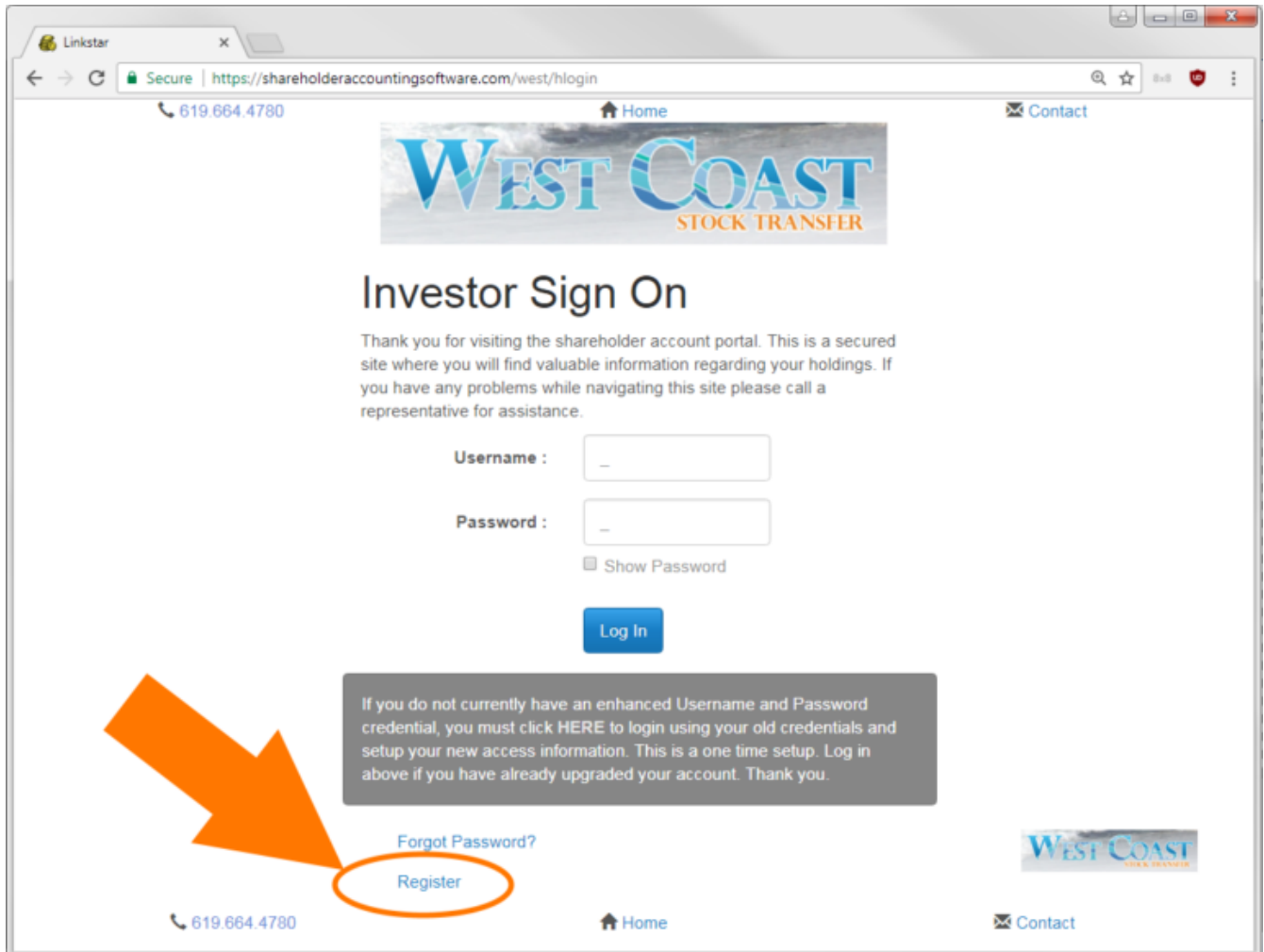

If you received a shareholder registration letter from West Coast Stock Transfer in the mail, or if this is your first time logging in:



Click the **Register** link in the bottom left to get started. On the next page; enter the 'Shareholder #' and the temporary password from your 'Book Entry Confirmation' mailing.

Your Shareholder # and temporary password are on your 'Book Entry Confirmation' mailer. The last 4 digits of your Tax ID is either the last 4 digits of your Social Security Number (SSN) or Employer Identification Number, if a business).
